#### ADOPTION SITE CLEANUP AGREEMENT

**AGREEMENT FOR PARTICIPATION OF MINOR under age 18. (REGISTER 1 MINOR / ONLINE FORM)**  
**No one under the age of 12 should walk the shoreline due to slipping/tripping and fall hazards. However, younger children can participate in other clean-up activities.**

- 1. PARENTS agree to allow their UNDER 18 participants according to the terms of this agreement. Cleanup of trash or man-made debris ONLY is allowed below the COE red line**
- 2. Stay off private property unless you receive permission from the owner.**
- 3. NO CLEANUP of natural debris, dead wood or weeds is authorized in this cleanup effort.**
- 4. Participants adopting a specific SPOT on the shoreline agree to a minimum of 3 cleanups per year.**
- 5. PARENTS should adhere to the following information to promote the safety of the minors.**
  - Volunteers are required to wear close-toed shoes and gloves to protect you from objects you may encounter (i.e. glass, metal, needles, snakes, etc.).**
  - Volunteers are strongly advised to wear pants, long sleeves and a hat to minimize issues with ticks, chiggers and poison ivy. Spraying clothing for ticks & chiggers is advised!**
- 6. Recognition & Contests:** IF you choose to be recognized or enter our contests for collection, then submit a PHOTO of your bags/items collected on the Friends of Rough River FACEBOOK page.  
***(A release to share your photos is understood to be included with the submittal of your online registration form.)***  
**Be sure to keep track of how many bags your child collected in total and let us know!!**
- 7. Parents are aware of the potential dangers of their minor children walking the shoreline and assume any risks associated with their participation in the clean-up effort.**

**8. Minors between the ages of 10 - 18 are allowed to participate. Anyone under 12 should not walk the shoreline. Anyone under the age of 18 must have a parent submit an ONLINE registration form for their participation.**

**I verify that my son/daughter is age appropriate to volunteer for this project.**

- **Minors up to 12 years old\*\*:** I also understand that I, as parent/guardian of said minor, agree that my child under the age of 12 should not walk the shoreline, but may participate in other cleanup activities.
- **Minor BETWEEN 12 & 18 years old\*\*:** I also understand that I must authorize this release for my child who is between the ages of 12 and 18, as of date of participation entered in window below. I agree he/she does not need to be accompanied by me, or an authorized custodian, in order to volunteer for this activity.

**MEDICAL TREATMENT AUTHORIZATION:** I verify that qualified emergency medical personnel, including a physician and staff, are authorized to examine the below-named minor child in the event of injury, and to administer any emergency care or treatment deemed necessary. In the case of a minor child, a reasonable effort will be made to contact the Parent/Legal Guardian prior to any treatment. I agree to be responsible for all necessary charges incurred as a result of any care or treatment rendered pursuant to this authorization.

**PHOTO RELEASE:** By submitting my online registration form, I hereby consent to and authorize the Friends of Rough River Lake, Inc., its publishers, licensees and assignees, permission to use and reproduce still photographs and/or film footage taken of me (and/or photos taken of my minor child/children) in whole or in part, with or without names, for editorial, trade or advertising purposes. I also confirm that I waive all claims arising from such use for any additional compensation, damages, and invasion of privacy.

**WAIVER & RELEASE:** In consideration of the following ("Minor") being permitted by The Friends of Rough River Lake, Inc. (FORRL) to participate as a volunteer in its Adopt-A-Spot PROJECT, I the ("Parent / Guardian") on behalf of me, my heirs, personal representatives and executors, hereby disclaim, release and waive any and all claims against the FORRL for personal injuries or damages to property sustained by Minor or any other person arising out of the PROJECT, including claims and damages arising in whole or in part from the negligence of the FORRL or its agents. By submitting my online registration form, including my consent to this release and waiver I am relying upon my own judgment, belief and knowledge. I acknowledge that if anyone is hurt or property is damaged during my minor child's participation as a volunteer, I may be found by a court of law to have waived my right to initiate or maintain a lawsuit against the Friends of Rough River Lake, Inc. on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I read and understand it, and I agree to be bound by its terms.
